A completed application must be received by the Grinnell Library at least seven days before the vote (Tuesday, September 24, 2019, by 5p.m.) if the ballot is to be mailed to the voter, or by the day before the vote (Monday, September 30, 2019 by 5p.m.) if the ballot is to be personally picked up at the Library. The completed ballot must be returned to the library no later than 5p.m. on the day of the vote (Tuesday, October 1, 2019).

Instructions for Absentee Ballot Application

1. All applicants for an absentee ballot shall complete, in its entirety, the application of the front side of this form and sign it. The applicant must also fully complete the outside of the absentee ballot envelope.
2. All absentee ballot applications must be received by the Grinnell Library, 2642 East Main Street, Wappingers Falls, New York 12590 at least seven days before the vote (09/24/2019), if the ballot is to be mailed to the voter; or the day before the vote (09/30/2019 by 5p.m.) if the ballot is to be personally picked up by the voter at the Library.
3. Where a person is or would be, if s/he were a registered voter, entitled to apply for the right to vote by absentee ballot under the provisions of this section, his/her spouse, child, or parent, if a registered voter in the District, shall be entitled to vote as an absentee voter upon personally making and signing an absentee ballot application showing that s/he expects to be absent from the County of the day of the Library election by reason of accompanying or being with the spouse, child, or parent who is or would be, if s/he were a qualified voter, so entitled to apply for the right to vote by absentee ballot.
